So I can mention here (also see filename) we are looking at Image 2 of 3 of a recent TAGGS.hhs.gov search for any and all grants to "American Humane Association" and in the context of noticing a publication citing to a wrong grant # as to a QIC-NRF although the word National" shows up in front, so you'd think the abbreviation might be "NQIC-" but "QIC" for 'Quality Improvemt Center seems to be the usage.
