She is the editor of the International Journal of Child Custody and co-editor with Kathryn Kuehne of Parenting Plan Evaluations: Applied Research for Family Court (Oxford University Press). She has co-edited other books on relocation, psychological testing, and child sexual abuse and written chapters on domestic violence, treatment of trauma, alienation, and unification therapy. Dr. Drozd has been a child custody evaluator for over 20 years, trains other evaluators, serves as a consultant to attorneys, and as a testifying expert in family law matters. She has helped write the Association of Family Conciliation Courts Model Standards for conducting child custody evaluations and for those parenting plan evaluations involving allegations of domestic violence. She also works clinically with families in the various stages of divorce including co-parenting therapy, family therapy, unification therapy, and parent coordinator. Dr. Drozd has spoken at conferences on these topics in America, Canada, and Europe. Most recently she was honored by the international Association of Family and Conciliation Courts with the John E.
