

THE DATA (Table of Search Results) BEGINS ON THE NEXT PAGE (=12pp). While this pdf printout eliminates the handy "alternating" row colors, the organization names (on any row) are still active links, which is why I did this printout.

The 197 results will represent fewer entities (like 60) as this data only shows 3 most recent years for any named entity.

I "limelighted (like this rectangle) any named JUST "Foundation for Educational Excellence" without any preceding descriptor (such as a donor name, a city name, a school district name, etc)

They were found in CO, TX, IL, NM, IA. However I just remembered also that this database has a somewhat lousy record at matching its search result names consistently with actual uploaded IRS tax form entity names (i.e., a click through may show a completely different filename).

It is sorted by \$\$ column.

Private school districts aren't named, so any reference to school districts here will refer to a (USA) PUBLIC Special-Purpose government entity, which such districts are. Other special-purpose gov't entities would include Sanitation, Health, Water, Transportation, etc. districts, however SCHOOLS are such a huge purpose, they are their own classification, apparently. POINT HERE: For every named entity below, some school district financial statements (=/= and "Annual Report" which is entirely different) would exist. I wonder how many people have ever located and read those CAFRS. I have run into people panhandling, excuse me, "soliciting" for a local (well-to-do) suburban independent school district INSIDE retail establishments; the practice was so accepted. NOT ONE person soliciting could locate, had read, or point me to the CAFR. I looked it up for their sakes. School districts CAFRs do not always surface as part of a COUNTY CAFR filer even if completely contained within the country. Those CAFRS are what should be found and examined FIRST before raising money for broke schools in ways which are hard to track.

(Scroll through for overview. The only annotations in following pages were to mark the entity names "Foundation for Educational Excellence" with green rectangles. I didn't even find the one I am blogging on currently.)
