I thought it interesting that although "NCADV" is a membership org. (charges fees for membership — although by far its larger contributions (recently tripled in size) are private, not "Membership fees" in fact in recent years it was down to just over \$1K net assets per its Form 990) this "Stay Connected/State Coalitions" was not under the main-menu link "About Us" or even something called "Members" but simply under "Stay Connected." Also what makes anything a "State Coalition" isn't defined — at all, that I can see — on the website. Wouldn't that be something a battered woman, man, mother (or father) might want to know from the website, that there is federal funding by category to the State Coalitions, and whether or not these listed here are recipients?

NCADV's tax returns (and the IRS Exempt Select Organization check (pub.78) listing show it as a Colorado (Denver, CO) entity, however it's only been authorized to do business in Denver — as a Foreign entity whose legal domicile is Oregon, since 1992. The OREGON nonprofit is still active and was first formed in 1978. Colorado Business Database only showed me the Oregon legal domicile....Interesting that 1992 was also the start of (Pres. Wm. J.) Clinton Administration, a few years before welfare reform of 1996 (which was by then in the works no doubt) and the FIRST re-authorization of the FVSPA, I believe.

This one is large and has gone through (or, represents) as I recall, several mergers. They are in Northern California near state capital, but they are NOT one of the "Special-Issue Resource Centers." Another California-based (legal domicile, again, as I recall) entity which claims responsibility for having gotten the VAWA passed (1994), and which entity seems to have incorporated around 1989 (as I recall) IS — and that's "Futures without Violence" formerly "Family Violence Prevention Fund." (Dir Esta Soler). I have blogged plenty on this before and after its 2010 namechange. Type "endabuse.org" for a redirect to the new website (former color scheme, red; current color scheme, more "green"). They have related entities and property in the SF Praesidio (I believe Federal property) now.

CPEDV (by contrast) has connected extensively with the health insurance foundations, who certainly enjoy the positive associations with such connections. Meanwhile, at the state level (for certain account #s) in about 1999 a change in certain funding from being simply "Domestic Violence" was split into "Domestic Violence Leadership and Education.".... as I researched that information some years ago and don't recall all the exact details am simply referencing it here.

I have lived in California (had children, was battered, filed for protection and got the standard 3-year-order which was promptly violated, repeatedly, it was then combined with a dissolution case seeking to switch custody. This never succeeded in court until the ex (and his new woman/girlfriend, who had the housing he did not — it's hard to have housing while attempting to dodge a work life and accountability for child support arrears —) simply refused to return our children from a court-ordered visitation. Devasating — but NEITHER of the two giant California Entities (This one, or "Futures") had any answers or help for me, or women in this situation. Futures and/or FVPPF, throughout, were, however busy doing "Men and Boys" outreach as well as Fatherhood Institutes, etc. (See my Jan. 2011 blog on "Rhetoric." Pardon my sarcasm, pls. but it's the truth. It took me a while to figure out why NO help was comgin from these quarters, or was about to.

(Red Arrow simply means variation from the "CADV" pattern in an entity's name) Functionally as to the TAGGS.HHS.Gov Grants database, this means one cannot use "name search" to discover who are and to view the domestic violence prevention grantees. Also under "Advanced Search" over there, as I am currently (see header date) blogging, the software (user interface) at TAGGS precludes — because the CFDA Numbers are just not listed, and no field exists in which to type them in — searching certain CFDA#s known to be associated with certain anti-domestic-violence programming authorized under the "FVPSA" Family Violence Prevention and Services Act (42 U.S.C. Chapter 110). Thus, you can't tell by name (which only makes sense — businesses incl. nonprofits can call themselves whatever they want, if the name is not in use by someone else at the time) AND can't run an advanced search by CFDA# for some numbers. There's no indication to the public on that form that numbers exist which are not listed, so people who don't ALREADY know or have previously noticed that such CFDA#s exist, may never know about the programs. There is no particular public need served by placing obstacles in research use of public funds, in my opinion.

Fatherhood organizations (and Children's Rights organization which are functioning in the same manner, incl. some religious ones feeding off the HHS grants streams) are, like DV organizations, also prone to networking. I recently explored MFFN.

So on any page (on this list), comments similar to those on the previous page could be made regarding various entities, state-by-state, working AGAINST women survivors of abuse retaining custody to their children, and having the fathers of the children be held accountable for paying basic, and sustained levels of child support. I realize that some CS orders are extortionist, but others are set below welfare level (in my case, it was) ... and the enforcement seems arbitrary. I was basically told, go hire yourself a lawyer and get it yourself, by the local agency, when the arrears was in the thousands, AND the protection order was off, complicating maintaining my own work. Only around 2009 did I learn, or did it catch my attention that some of the reluctance to actually enforcing orders is that it may be more profitable for the state (and counties, and related nonprofits) to let things run their course, help the father regain more visitation time — if not complete, sole custody (i.e., custody-switching), keeping up the "numbers" for those federal incentives. TITLE IV-D of Social Security Act (which refers to child support enforcement) is where the Access and Visitation Grants are authorized, while Title IV-A, the Healthy Marriage and Responsible Fatherhood acts, both based on the concepts of public welfare.

The CADV organizations could easily have informed their battered mother clients (i.e., people with DV issues and minor children) what they were up against before deciding to file. INSTEAD, they help the first part of the process, then dump the survivors off into the family court venue, where there is more public-policy help to the other side of the custody case. If women who are facing this type of case-churning, custody challenge are not starved out (through reduction of child support arrears while being harassed as to their own functional lives through the legal cases), they might be litigated into ongoing trauma and forced dealings with these violent men. AGAIN, I do not say ALL men.

It may be too late, but it's still time to call-out these CADV organizations on the "don't ask, don't tell" regarding HHS grants to fathers' rights organizations (and other sources of the same, including private), and no excuses for CADV ignorance, either. They are feeding from basically the same public agency troughs.

("ODVN.org" is involved in the Ohio IPV Collaborative and acknowledged (by BWJP among others) to be for this purpose taking funding from "The HealthPlan Foundation of Ohio" which, complete with a name-change in 2010 from "Anthem" (Foundation...Ohio) got started a certain year (not in front of me, but I think it was 1998) with a capital injection of \$28,000,000 (!!!, !!!, !!!) and has been simply living off that (there are no particular program service revenues or org. activities other than grants). HealthPlan Foundation of Ohio is itself a "related entity" of the Greater Cincinnati Foundation," much larger and functioning as a (tri-state? OH, KY, PA) community foundation. Interesting, huh?
DISCLAIMER: I've been studying this but don't have perfect recall or photographic recall and sometimes do mix up one entity with another; nothing that can't be fact-checked by any reader, and (assuming it's been published) from the related post (which will provide links to the evidence) on my blog. Anyhow, there is no way that these nonprofit coalitions with their federally designated HHS funding allotments under FVPSA, can compete with major foundations (such as those associated with George Soros/Open Families, Ford, Annie E. Casey, or even here, this strange HealthPlan Ohio which (now I'm remembering more) has as its specific exempt purpose (one of 3 purposes) to fund the IPV Coalitions (the other two were dental services and children's mental health, I think).

PCADV is (or at least was) designated as one of the "four special-issue resource centers" (and has related entities or centers going on also) and also (I'm sure as do some others) taking USDOJ grants under the OVW (Office of Violence against Women). So its revenues will be larger. I'd say more, but I have posted some of the grants over time, and am in a current post hoping to publish by 3/6/2017. It's a major grantee and player in the DV network nationwide — much larger than, say, the "NCADV."

So far as I can see, this is a government office (Puerto Rico) and as such would of course not be named as a "state" coalition against domestic violence. Notice the IS gender-specific, but is NOT limited to just DV issues.

It would definitely be a power hub in the field, and as the TAGGS.hhs.gov database has since changed such that you (that I can tell) can NO LONGER search by EIN#, that might be hard to straighten out. I see in Texas it's a FAMILY (not a "Domestic Violence") matter, which make sense it being Texas. "Domestic Violence" would be too "feminist."

Looks like (is) two offices listed for one organization. I wonder if any other state coalitions have more than one office. The only other state (on this list) showing more than one entity is OHIO (and, as I found, one of those entities, Action Ohio Coalition for Battered Women, has been operating at an increasing DEFICIT (budget AND net assets or fund balances), without exception since about 2001 (and possibly before, but I don't have tax returns any earlier). It doesn't have assets, it has debt. (see blog). One thing I do know is that many states have other "DV" or "Violence Prevention" organizations, significant one, but they are not considered "state coalitions" for some reason, and apparently not by NCADV. I wonder how many of these are also reference in NCADV's website as "Other Organizations," and how many just may not be. I also wonder if there is any connection between membership in NCADV (their dues revenues are NOT that high compared to other revenues) and being listed on that web page.
