Box in this color blue (near bottom), basically says that ONE board member only (Patrick T McCarthy) (title or function omitted) works FT and so is included on Line 2 (5 highest-paid employees) (not Line 1, where as board member, he should be listed, opposite his function, hrs/week and salary!

Name: THE ANNIE E CASEY FOUNDATION INC

By listing (on that part) just a "Total" figure

EIN: 52-1951681 (over \$2.2M as I recall)

AECF deliberately avoids citing a Board Members' salary where the public might read it.<==<==<==

Form 990PF (pre-printed or electronically formatted) which had COLUMNS for CLARITY. AECF observed columns for its \$105/6M of grantees, for its subcontractors (the first 5 anyhow) and many other parts of the return but when it came to naming their own leadership, "fudged" and presented it in this fashion. WHY? is a good question...

4 black arrows show 4 trustees paid \$25K for working fewer than 4 hrs/week.

This is a pitiful (& deceitful) double-dodge. First, he's not listed on the form (nor is anyone else who should be) THEN his salary isn't posted here, either! (or title).
