This is an electronic form, and based on how this information requested by IRS to be in table format was presented (at the back end of a long return) I'd have to speculate that someone wasn't too interested in advertising just what was being paid to whom.

MANY organizations do "See additional Table" and provide it later — but in columns. AECF did not. This CANNOT be from lack of resources to produce a coherent tax return listing of their officers, directors, and (Pt. VIII Ln2) "five highest paid employees over \$50K. Why not list those 5 right here?

For some reason, it was judged OK to cough up the five highest-paid independent contractors (Pt VIII Line 3 starting on next page), so what's with the decision regarding Lines 1 & 2 here?
